Three worship services will be offered on December 24. A traditional candlelight will be held in the Sanctuary at 3:00 PM. A contemporary Christmas Eve service will be held in the WROC at 5:00 PM, and a second traditional service will take place in the Sanctuary at 8:00 PM.

ASSOCIATE PASTOR'S REPORT

Rev. Bentley and elder Carol Galbreath attended the meeting of the Pittsburg Presbytery at Crestfield on September 28. The Deacons will offer *Deacons with Donuts* each Sunday in November. Deacons will be offering donuts in the North Entrance Welcome Center and will be available to discuss the many projects that the Deacons are pursuing at Westminster. Harrison Burgess, Associate Director of Youth Ministry, is spearheading a program to send Care Packages to College Students.
